### **POLICY STATEMENT:**

The Board recognizes that appropriate and responsible use of personal electronic devices enhances student learning. At no time should these devices interfere with an individual's right to privacy, the student's right to a safe and caring environment or the teaching and learning process.

### **GUIDING PRINCIPLES:**

- 1. The Board does not provide nor expect students to provide personal electronic devices for educational purposes that extend beyond the requirements of the curriculum.
- 2. All personal electronic devices must be turned off and out of sight during instructional times or in spaces where instruction is occurring, except with the specific permission of the principal when their use is planned, purposeful and educationally motivated.
- 3. Limited use of personal electronic devices must be permitted, as determined by a principal for health or medical reasons or to support special learning needs with appropriate documentation.
- 4. Use of electronic devices is prohibited in change rooms and washrooms and therefore they must

be turned off and out of sight. Appropriate signage will be posted to this effect.

- 5. In consultation with staff, students and parent council, a principal may choose to adopt a schoolbased electronic device policy for non-instructional times and spaces.
- 6. Use of personal electronic devices during school-related activities is subject to the provisions of Policy 303BP Use of Division–Owned Technology, 304BP Personal Electronic Devices and privacy legislation under the *FOIPP Act*.
- 7. The use of personal electronic devices shall not:
  - 7.1 interfere with student learning;
  - 7.2 compromise personal safety or the safety and well-being of others;
  - 7.3 infringe upon an individual's right to privacy;
  - 7.4 interfere with the operation of the jurisdiction.
- 8. Should a student contravene this policy the electronic device will be subject to a progressive discipline approach to address violations.
- 9. Any staff contravening this policy shall be subject to disciplinary action under Board policy and the *Education Act*.
- 10. The Board expects that all visitors will respect this policy. Those that contravene this policy will be asked to comply or to leave the building and may be subject to disciplinary action under Board policy and the *Education Act*.
- 11. The principal must annually inform stakeholders, in writing, of this policy and procedures.
