

THE BUFFALO TRAIL SCHOOL DIVISION BYLAW NO. 01-2024

ELECTORAL WARDS

WHEREAS section 76 of the *Education Act* provides that the Board of Trustees may by bylaw establish the wards and provide for the nomination and election of trustees in the wards;

THAT the Board of Trustees determines under this bylaw for the nomination and election of trustees to be by the residents of wards which shall be comprised of a total of seven (7) wards and seven (7) elected trustees;

THAT for each ward one (1) trustee is to be nominated and elected;

THAT the Board of Trustees establishes under this bylaw the seven (7) wards as follows:

WARD 1: North-West

Encompassing the north-west of the school division including the communities:

- in areas of the County of Minburn, the County of Vermilion River, the Municipal District of Wainwright; AND
- in the Village of Innisfree, the Village of Mannville; AND
- in the Hamlet of Clandonald, the Hamlet of Minburn; AND
- in the Holt Hutterite Colony, the Mannville Hutterite Colony, the Mixburn Hutterite Colony, the Spring Ridge Hutterite Colony; AND
- excluding the Town of Vermilion and surrounding area; AND

DEFINED AS:

North Boundary: the boundary of the school division;

West Boundary: the boundary of the school division;

South Boundary: starting south-west at Township Road 470 and Range Road 105: east on Township Road 470 to Township Road 465B, and then east to Township Road 470, and then east to Township Road 470A, and then east to Township Road 470 to Range Road 71, and then straight east past Highway 41 to Township Road 470A, and then east to Range Road 63A, and then straight east to Township Road 470, and then east to the end of the easterly direction of Township Road 470, and then straight east to Range Road 470, and then east to Range Road 470, and then east to Range Road 470, and then east to Range Road 44;

East Boundary: starting south-east at Township Road 470 and Range Road 44: north on Range Road 44 to the end of Range Road 44, and then straight north to Range Road 44,



and then north to Highway 893, and then north to Highway 45, and the east to Highway 893, and then north to the school division border;

EXEMPTING that area defined as WARD 2.

WARD 2: Town of Vermilion and Area

Encompassing the north-central of the school division including the communities:

- in areas of the County of Vermilion River; AND
- in the Town of Vermilion; AND

DEFINED AS:

North Boundary: that area south of Township Rd 520;

West Boundary: that area east of Range Road 80;

South Boundary: starting south-west at Township Road 492 and Range Road 80: east to Highway 41, and then directly east to Range Road 64 to Township Road 491A, and then east to Township Road 492, and then east to Range Road 54;

East Border: starting south-east at Township Road 492 and Range Road 54: north to Highway 16, and then west to Range Road 55, and then north to Township Road 510, and then west to Range Road 55, and then north to Township Road 520.

WARD 3: North-East

Encompassing the north-east of the school division including the communities:

- in the areas of the County of Vermilion; AND
- in the communities of the Village of Kitscoty, the Village of Marwayne; AND
- in the Hamlet of Blackfoot, the Hamlet of Dewberry, the Hamlet of Streamstown, the Hamlet of Tulliby Lake; AND
- in the O'Brian Hutterite Colony; AND

DEFINED AS:

North Boundary: the boundary of the school division;

West Boundary: that area east of Highway 893;

South Boundary: starting south-west Highway 619 and Highway 893: east on Highway 619 to the east boundary of the school division;

East Boundary: the boundary of the school division.



WARD 4: Central-West and South-West

Encompassing the central-west and south-west of the school division including the communities:

- in areas of the Municipal District of Provost, the Municipal District of Wainwright;
 AND
- in the Village of Amisk, the Village of Czar, the Village of Hughenden, the Village of Irma; AND
- in the Hamlet of Fabyan; AND
- in the Rosewood Hutterite Colony; AND
- excluding the Town of Wainwright and 3rd Canadian Division Support Base Detachment Wainwright (Denwood, AB); AND

DEFINED AS:

North Boundary: starting north-west at Township Road 470 and Range Road 104: east on Township Road 470 to Township Road 465B, and then east to Township Road 470, and then east to Township Road 470A, and then east to Township Road 470, and then east to Township Road 465A, and then east along Township Road 470 to Range Road 71, and then straight east to Highway 41;

West Boundary: the boundary of the school division;

South Boundary: the boundary of the school division;

East Boundary: starting south-east at Highway 599 and Highway 41: north on Highway 41 to the south boundary of Ward 5 (Denwood, AB), and then east/north/west following the border for Ward 5 (Denwood, AB) to Highway 41, and then north to the south boundary of Ward 1;

EXEMPTING that area defined as WARD 5.

WARD 5: Town of Wainwright and Area

DEFINED AS the area comprising the Town of Wainwright and 3rd Canadian Division Support Base Detachment Wainwright (Denwood, AB).

WARD 6: Central-East

Encompassing the central-east of the school division including the communities:

- in areas of the County of Vermilion River, the Municipal District of Wainwright; AND
- in the Village of Chauvin, the Village of Edgerton, Village of Paradise Valley; AND



- in the Hamlet of Greenshields, the Hamlet of McLaughlin, the Hamlet of Rivercourse;
 AND
- in the Ribstone Hutterite Colony; AND

DEFINED AS:

North Boundary: starting at the north-west corner of Ward 4 at Highway 41: east to Township Road 470A, and then east to Range Road 63A, and then straight east to Township Road 470, and then east to the end of the easterly direction of Township Road 470, and then straight east to Township Road 470, and then east to Range Road 44, and then north on Range Road 44 to the end of Range Road 44, and then straight north to Range Road 44, and then north to the intersection of Highway 893 and Highway 619, and then east along Highway 619 to the school division border;

West Boundary: starting at the north-east corner of Ward 4 at Highway 41: south following Highway 41 to Ward 5, and then east and south following the Ward 5 (Denwood, AB) boundary to the boundary for the Municipal District of Wainwright, and then south along the boundary for the Municipal District of Wainwright to where the boundary for the Municipal District of Wainwright turns east;

South Boundary: that area north of the Municipal District of Wainwright and the Municipal District of Provost boundary;

East Boundary: the boundary of the school division.

WARD 7: South-East

Encompassing the south-east of the school division including the communities:

- in areas of the Municipal District of Provost; AND
- in the Town of Provost; AND
- in the Hamlet of Bodo, the Hamlet of Cadogan, the Hamlet of Hayter, the Hamlet of Metiskow; AND
- in the Hughenden Hutterite Colony; AND

DEFINED AS:

North Boundary: that area south of the Municipal District of Wainwright and the Municipal District of Provost boundary;

West Boundary: starting at the corner where Highway 41 intersects the Municipal District of Wainwright and the Municipal District of Provost boundary: south following Highway 41 to the school division boundary;

South Boundary: the boundary for the school division;

East Boundary: the boundary of the school division.
